



## **SALESIANUM, ZUG – Public Announcement, November 9<sup>th</sup> 2018**

The N. Nikolajsen family is happy to announce having entered into an agreement with Alfred Müller AG to purchase, renovate and restore the Salesianum, also known as the St. Karlshof - one of the most prominent historical properties on the lake of Zug.

Alfred Müller AG purchased the Salesianum from the Institute of Menzingen in 2011, and ever since the long-term future of the property has remained open.

Over the next two-and-a-half years, Alfred Müller AG and the N. Nikolajsen family will be working together to properly renovate, restore and refurbish the property and bring it back to its former glory.

It is the intention to utilize the Salesianum for residential purposes, with the notable exception of the St. Karl Borromäus chapel (built 1615), which is to be restored and opened to the public as a museum dedicated to the history of the

Throughout the renovation and restoration, the utmost care will be taken to protect and respect the authenticity and integrity of this historic Zuger landmark, as well as to work closely with the town and the Kanton of Zug to this effect.

It is the hope of Alfred Müller AG and the N. Nikolajsen family that the result of the agreement which is announced today, and the renovation project which will now follow, is to both restore and preserve the exceptional and historic property which is the Salesianum / St. Karlshof, for the present as well as for future generations.
